

# 2021-2022 TUITION PAYMENT PLANS

## Registration Fee

A registration fee of **\$200.00 is required** for each student, which will be deducted from your tuition. This fee is payable at the time classes are scheduled for the 2021-2022 school year.

## PAYMENT OPTIONS

- Plan I** Full payment of tuition and fees directly to the school by 08/16/21.
- Plan II** Two equal payments of tuition and fees. **BOTH PAYMENTS MUST BE PAID THROUGH FACTS.** Payments are due in August 2021 and January 2022. A \$10.00 processing fee will be charged by FACTS.
- Plan III** Four equal payments of tuition and fees which **MUST BE PAID THROUGH FACTS.** Payments are due in August and November of 2021 and February and April of 2022. A \$45.00 processing fee will be charged by FACTS.
- Plan IV** Ten equal payments of tuition and fees beginning August 2021 which **MUST BE PAID THROUGH FACTS.** A \$45.00 processing fee will be charged by FACTS.

You may select the 5<sup>th</sup> or 20<sup>th</sup> of the month for your payment date.

**Plan III** Four equal payments of tuition and fees through FACTS. Payments are due in August and November of 2021 and February and April of 2022. **ALL PAYMENTS MUST BE PAID THROUGH FACTS.** A \$45.00 processing fee will be charged by FACTS.

**Plan IV** Ten equal payments of tuition and fees beginning August 2021 through FACTS. **ALL MONTHLY PAYMENTS MUST BE PAID THROUGH FACTS.** A \$45.00 processing fee will be charged by FACTS.
